Before completing this form, please ensure the vehicle meets ALL of the eligibility criteria in this application for a Collector Motor Vehicle. Incomplete applications will be rejected.

Regardless of the vehicle's age, it must meet ALL of the condition requirements to be eligible as a Collector Vehicle (see Step 3 Vehicle Condition and Equipment Requirements). ICBC reserves the right to apply additional eligibility criteria when determining a vehicle's Collector Vehicle Status in accordance with the Motor Vehicle Act Regulations.

Eligibility Criteria

STEP 1 – Age Requirements

Vehicles must meet one of the following age categories to be eligible for the Collector Vehicle Program.

The vehicle is:

- registered in BC; and
 - registered in the name(s) of the registered owner(s) in this application.

AND

The vehicle is ONE of the following:

- □ 25 years old Vehicle Model Year
- □ 15 years old **Discontinued Vehicle** is one where the manufacturer that owns the "trademark" or "make" of that vehicle has ceased manufacturing vehicles of any kind for at least the last five years. You will need to provide proof that's acceptable to ICBC.
- □ 15 years old Limited Production Vehicle is one of no more than 1,500 of that make and model (not edition) produced worldwide* by the manufacturer for that model year.

*You will need written proof from the manufacturer on its letterhead identifying the total number of vehicles produced **worldwide**. The letter must also indicate the make, model, and model year of your vehicle and quote the full vehicle identification number (VIN). If a letter outlining the worldwide production numbers for the vehicle cannot be obtained from the manufacturer, you will need to provide other proof that is acceptable to ICBC that clearly demonstrates the worldwide production numbers.

STEP 2 – Vehicle Customization Restrictions

Vehicles must be stock or only have parts and accessories that are listed on the Approved Parts and Accessories to be eligible for the Collector Vehicle Program.

Contains non-stock parts and accessories that are on the Approved Parts and Accessories List (see page 5 of this application). List all approved non-stock items installed on the vehicle:

Regardless of the vehicle's age, it must meet ALL of the condition requirements to be eligible for the Collector Vehicle Program.

The vehicle is in the following condition (all items below with the exception of convertible must be met and checked off or the application will be rejected):

- □ Vehicle exterior The vehicle's exterior is clean, detailed and in excellent original or restored condition with no dents, scrapes, chips, paint blemishes, bubbling, rust, or visible primer.
- Vehicle interior The vehicle's interior is clean, detailed and in excellent original or restored condition with no tears, stains, or significant wear. Minor neat repairs to the original upholstery are acceptable.
- □ Vehicle repairs All repairs to the vehicle are completed according to professional practices and standards.
- □ Wheels The wheels are original or era correct and no larger than 1" taller or 1" wider than stock.
- Engine/Engine compartment The engine/engine compartment is clean and detailed with no damaged, deteriorated or rusted parts.
- Performance enhancements There are no performance enhancements and all permitted engine "dress-up" is era correct.
- Stickers and advertising The vehicle has no stickers or advertising of any kind. Exceptions are allowed to show affiliation with a collector vehicle club or for original dealer nameplates or decals that were dealer or factory installed.
- □ (Optional) Convertible Top If applicable, the convertible top has no damage and is in good working order.

STEP 4 – Vehicle Use Declaration

Collector vehicles must not at any time be used for driving to or from, or part way to or from, work or school or for any business purpose of commercial use.

Please select ONE of the following options. I confirm the following is true:

- □ The collector vehicle will be used solely for pleasure purposes, and cannot be used for general transportation, and will not at any time be used for driving to or from or part way to or from work or school or for any business purpose or commercial use.

Note: Upon licensing and insuring and on subsequent renewals, you will be required to inform your Autoplan broker of the licence plate number of your non-collector general transportation vehicle. If the only vehicle you have is your collector vehicle, you may still display collector plates on your motor vehicle, however you won't qualify for the reduced collector insurance premium. In addition, the collector motor vehicle must be rated for pleasure use only, and must not at any time be used for driving to or from, or part way to or from, work or school or for any business purpose or commercial use.

STEP 5 – Vehicle Photographs

Applications submitted that do not meet all the listed photograph requirements will be rejected. Photos will not be returned. Every new application will require new photos.

You will be required to provide additional close up photographs if the photographs you submit do not provide clear detail of the vehicle's condition.

All images must be:

- taken within 90 days of mailing your application;
- of the current vehicle condition and equipment;
- taken when the vehicle is clean and dry;
- taken in a well-lit area (no shade/shadows);
- taken straight on, and not on an angle;

STEP 7 - Statement of Applicant

For Licensing Purposes:

I declare that:

- a) I am a resident of British Columbia;
- b) the motor vehicle described above is in, and will remain in, a condition that makes it of significant value to a collector or exhibitor of motor vehicles by adhering to the requirements provided in step 3 Vehicle Condition & Equipment Requirements.
- c) the vehicle has been maintained or restored, and will remain in, a condition which conforms to the vehicle manufacturer's original specifications with the exception of upgrading of brakes, headlights and the installation of seatbelts, safety glass or other items satisfactory to ICBC.
- d) the attached colour photos are of the stock/approved parts and accessories vehicle and accurately show the current condition of the vehicle.
- e) the vehicle is at least:

i. 25 years old; and

OR

- ii. 15 years old; and
 - (a) is a "Limited Production Vehicle" (see definition in Step 1), or
 - (b) is a "Discontinued Vehicle" (see definition in Step 1).
- f) when licensed as a collector vehicle, it will be used solely for pleasure purposes and will not at any time be used for driving to or from, or part way to or from, work or school or for any business purpose or commercial use.

For Insurance Purposes:

I declare that when the vehicle described above is licensed and insured as a collector vehicle at the reduced collector vehicle premiums:

- a) it will be used solely for pleasure purposes and not for driving to or from, or part way to or from, work or school, or for any business purpose or commercial use and,
- b) I own or lease another licensed non-collector motor vehicle or motorcycle, or have a licensed non-collector motorcycle or other motor vehicle as a company assigned vehicle that is insured for general transportation purposes in one of the following rate classes 001, 002, 003, 004, 005, 007, 011, 012, 013, 014, 015, 017, 021, 022, 023, 024, 027, 310 to 314, or 320 to 324.
- c) I will continue to maintain the vehicle in the condition regardless of age at all times during the original and each subsequent licence/insurance policy term.

WARNING - INSURANCE COVERAGE AND CONTINUED ELIGIBILITY IN THE COLLECTOR VEHICLE PROGRAM

1. Insurance coverage may be forfeited if the vehicle described above:

- (a) is used contrary to the statements made above under "For Insurance Purposes",
 - (b) has been modified beyond the safety modifications permitted above, or
- (c) does not conform to the manufacturer's original specifications and has any aftermarket, non-factory options or accessories installed other than those permitted in the Approved Parts and Accessories List (page 5).
- If these conditions are not met, I understand that the vehicle will not be eligible as a collector vehicle and the collector vehicle insurance rate class and that I must immediately contact an Autoplan broker to obtain appropriate licensing and insurance for my vehicle.

I acknowledge that if the vehicle is used for more than pleasure purposes at any time after the initial application and approved as a Collector vehicle, the vehicle is no longer considered to be eligible for the Collector Vehicle Program.

Where the applicant gives false particulars to the prejudice of the corporation or knowingly misrepresents or fails to disclose in this application any fact required to be stated herein, or uses the motor vehicle contrary to the statement made above, insurance coverage may be forfeited. ICBC reserves the right to apply additional qualifying criteria when determining a vehicle's collector vehicle eligibility in accordance with the Motor Vehicle Act Regulations.

In signing this application, I declare that all the foregoing statements are true, and that I make these declarations with the intention that the Insurance Corporation of British Columbia will rely on the same.
